COUNTRY® Capital Management Company ("COUNTRY Capital") has developed a Business Continuity Plan ("BCP") for how we will respond to events that significantly disrupt our business. Since the timing and impact of disasters and disruptions is unpredictable, we must be flexible in responding to actual events as they occur. With that in mind, we are providing you with this information on our BCP.

Our Business Continuity Plan - We plan to quickly recover and resume business operations after a significant business disruption and respond by safeguarding our employees and property, making a financial and operational assessment, protecting the firm's books and records, and allowing our customers to transact business. In short, our BCP is designed to permit our firm to resume operations as quickly as possible, given the scope and severity of the significant business disruption.

Our BCP addresses: data back-up and recovery; all mission critical systems; financial and operational assessments; alternative communications with customers, employees, and regulators; alternate physical locations of employees; critical supplier, contractor, bank and counterparty impact; regulatory reporting; and assuring our customers prompt access to their funds and securities if we are unable to continue our business.

Varying Disruptions - Significant business disruptions can vary in scope, such as only our firm, a single building housing our firm, the business district where our firm is located, the city where we are located, or the whole region. Within each of these areas, the severity of the disruption can also vary from minimal to severe.

In a disruption to only our firm or a building housing our firm, we will transfer our operations to a local site when needed and expect to recover and resume business within three(3) to six(6) days.

In a disruption affecting our business district, city, or region, we will transfer our operations to a site outside of the affected area, and recover and resume business within fifteen(15) days.

In either situation, we plan to continue in business, transfer operations to our product sponsors, if necessary, and notify you through our website www.countryfinancial.com or our customer emergency number, 1-800-422-8261, how to contact us.

Contacting Us - If after a significant business disruption you cannot contact us as you usually do by contacting your local financial representative, you should call our home office number 1-866-551-0060 or go to our website www.countryfinancial.com. If you cannot access us through either of those means, you should contact one of the following product sponsors for instructions on how it may provide you prompt access to funds in your account or policy, enter orders for such account or policy, and process other transactions for such account or policy.
